## **DIRECTORS' REPORT**

# THE MEMBERS OF HOME INSECT CONTROL ASSOCIATION ("COMPANY").

Your Executive Committee Members have pleasure in submitting the **Twenty fifth Annual** Report of the Company together with the Audited Statement of Accounts for the year ended **31**st **March, 2020.** 

#### **PREAMBLE:**

Home Insect Control Association (hereinafter referred to as "Company") was incorporated on June 2<sup>nd</sup>, 1995 as Company governed under Section 8 of the Companies Act 2013.

The focus area of the Company is to promote and assist in the development of the household insecticides industry in the larger interest of the country, to make known the contribution of the household insecticides industry to the health and welfare of the community, to maintain and enhance the reputation of the household insecticides industry and co-operate with Government authorities, public bodies, institutions or associations and create awareness among trade, consumers.

#### **AUDITORS:**

M/s. M K Varghese & Co., Chartered Accountants are the statutory auditors of the Company.

M/s. M K Varghese & Co Chartered Accountant having registration no F 118836 W, Mumbai is retiring as Statutory Auditors of HICA in forthcoming AGM. M K Varghese & Co is reappointment statutory auditors of the company to hold office from the conclusion of the 24<sup>th</sup> Annual General Meeting for 2018-2019 till the conclusion of 29<sup>th</sup> Annual General meeting that is till 2023-2024. To consider re-appointment of M K Varghese & co, if eligible, as Statutory Auditors of HICA for such period and on remuneration/fee to be fixed by the EC.

Further as per the provisions, the appointment of Statutory Auditors needs to be ratified by the Members at every Annual General Meeting. Accordingly, the Company seeks ratification by the members of the re-appointment of the Statutory Auditors at this 25rd Annual General Meeting.

#### **GST**

During the year your company has taken registration under Goods and Sales Tax Act to ensure better compliance.

#### **PUBLIC INTEREST CAMPAIGN AGAINST THE ILLEGAL INCENSE STICKS;**

Your Company continued to focus on fight against the menace of illegal pesticide laced agarbattis / incense stick proliferated in markets across India and took up a challenge of Public awareness campaign with the initiative of certain members and produced TVC through professional teams and arranged broadcasting of TVC via electronic media like mass media, digital platforms, cinema houses, television. Such campaign generated desired result for the benefit of the consumers at large. The licensing of TVC to member has been permitted and upon grant of such license member is free to run TVC in the market of his choice at its costs.

Contributions from the members towards this special purpose activity fund have been received or receivable during current financial year.

#### **PLASTICS**

Your Company continues to follow up with various Govt. authorities for treating PET packaging used in Home insecticide products at par with exemption granted to medicine. Other State Governments have also started implementing the central Plastic Waste Management (PWM) Rules emphasizing the industry's Extended Producer Responsibility (EPR) obligations and issued directives to manage plastic waste, collect or buy back the plastics thrown in circulation so as to reduce overall impact of plastics.

Your Company has previously taken up the issue with Government of Maharashtra, other Agriculture Ministry authorities with regards to HI products through representations seeking exemption on the lines indicated to medicines/drugs.

Certain other initiatives are being kept in dialogue/progress with MOEFCC by leading industry bodies to provide options for effective implementation of plastic waste management. Members are being made aware that this PWM Rules and implementation of the EPR obligations by State Pollution Control Boards or Urban local bodies from time to time.

# **AMENDMENT TO ARTCILES OF ASSOCIATION**

You Company's articles of association stand amended to enlarge scope and definition of insecticides to cover any drug including an Ayurvedic, Siddha, Unani or Homeopathy and such other preparation based on traditional knowledge and/or a substance in any form, deemed as a 'drug' 'ayurvedic drug' by the Central Government under the Drugs and Cosmetic Act, 1940 read with relevant Drugs and Cosmetics Rules and includes any statutory modifications, amendments, re-enactment, rules and clarifications thereof from time to time. Consequent compliance under Companies Act 2013 has been completed.

#### Safe to use product logo

HICA efforts are ongoing to help members and consumers to distinguish genuine home insecticides products of members of HICA distinctively. In the market spurious, misbranded agarbattis and other insecticide products are occupied. HICA for distinguishing and differentiating the genuine CIB-RC or FDA registered products of members of HICA against non-members conceived approved and adopted logo of HICA as certification at last AGM with appropriate tagline, device and other element of the member product logo, the Executive committee has been empowered to freeze the logo in view of interests of HICA members and the changing external environment to safeguard, educate the consumers and protect reputation of HICA member products. The use of logo on genuine products of HICA members will be voluntary for members and will also attract license fee payable to HICA on an annual basis or fixed cost per annum or block of years under proper written agreement to regulate the use, promotion and defending such new logo of HICA.One member, so far, has indicated interest in using such logo.
